- Proof of recent financial capability (audited books, bank statements) for the past 2-3years.
- Bank details in the Company name.
- Two letters of recommendation (past clients, business partners, government/public entities, industry experts or consultants).

Pre-qualification documents shall only be sent to **procurement@openspaceyouth.org** with subject matter "Bid for Pre-Qualification – code (Indicate code for relevant category applied for).

Size of the Document should not exceed 5mb.
